AFA's virtual AGM set for January 19. Here's how to register.

Our next Annual General Meeting is going virtual. The event will be held online on **Tuesday**, **January 19, 2021**. AFA's business meeting, resolutions and elections will take place between 10 a.m. and 12 noon. A webinar will be offered between 1 p.m. and 3 p.m.

"For the first time, our AGM will be delivered entirely online," says AFA Executive Director Shannon Scofield. "We have important business to conduct as an organization, but we need to do it in a way that keeps everyone healthy and safe."

AFA members have several ways to register for the 2021 AGM. We invite you to fill out the registration form at the bottom of this newsletter. It can be mailed, faxed or emailed to AFA. Members can also register via the AFA website, <u>www.afaonline.ca</u>.

"We appreciate the willingness of our members to attend the AGM virtually," says Scofield. "If anyone would like help in getting the AGM set up on their computer, please don't hesitate to ask."

GFOs work together to support AgriStability changes. Your voice will help.

In recent weeks, AFA has worked closely with our fellow General Farm Organizations on the Prairies to highlight new federal government proposals to improve AgriStability. These changes include increasing the AgriStability payment cap from 70% to 80% and removing the Reference Margin Limit. AFA believes that the Government of Alberta should accept these proposals and work with the Government of Canada to implement these changes to AgriStability, effective for 2020.

These are the key points we've been making:

- This proposal is supported by the membership of the Canadian Federation of Agriculture, which represents over 200,000 farm families across Canada.
- This is the first new federal money to potentially come into AgriStability since 2013.
- If these changes are adopted this year, they would be retroactive for 2020 and will be forward-looking to 2021 and 2022.
- This is meaningful short-term progress on Business Risk Management. We can achieve even more in the next Agricultural Policy Framework in 2023.

Getting AgSat ready for launch

AFA continues to work with our partners Aquanty Inc. to bring AgSat to market in Spring 2021. AgSat is an online toolbox of open source and satellite information that provides farm producers across Canada with essential data on their land. This includes soil moisture, soil temperature, precipitation, vegetative growth and more.

A unified front on private rail crossings

The November 28, 2021 deadline for landowners to meet new grade crossing requirements in Western Canada has emerged as a serious producer concern. AFA, APAS and KAP recently called for the federal government to extend the deadline. The pandemic has created conditions that will make it logistically difficult for landowners to comply. AFA President Lynn Jacobson also sees significant cost outlays facing affected producers.

"From the bills that we have seen so far, farmers could be expected to pay tens of thousands of dollars depending on the work that has to be done," Jacobson says. "That work and extra cost, especially during a pandemic, creates additional uncertainty and pressure with a looming deadline."
